### **GUIDELINES FOR THE LEGAL FRAMEWORK**

### **OVERVIEW OF THE EXISTING LEGAL FRAMEWORK:**

 81 analysed legal acts
 Overview divided into 16 chapters
 Legal acts adopted at international, EU, national and regional level









#### **GUIDELINES FOR THE LEGAL FRAMEWORK:**

 Partner countries are signatory parties of international legal acts
 Partner countries, EU members, harmonized their legislations
 Non – member states have started the harmonization process









#### **GUIDELINES FOR THE LEGAL FRAMEWORK:**

Joint efforts of all partner countries within international organisations in establishing an improved legal framework:



- first step: review transport policy and its compatibility with broader policy aspects, especially those concerning infrastructure and connections between different transport modes
- second step: review the legal acts that regulate the passenger transport







### **GUIDELINES FOR THE LEGAL FRAMEWORK:**

Partner countries which are not EU
member states should continue
to harmonize their national legislations
with acquis communautaire and to
implement the following activities:



- analysis and monitoring of harmonization degree of national legislation
- adoption of appropriate methodology and measures
- continuous cooperation with EU institutions
- elaboration of strategic documents and reports
- supervision of the harmonization process
